

FUND MANAGER'S COMMENTARY

The Fund achieved a return of +2.91% in March 2024, outperformed the benchmark by 58bps. The outperformance was due to the overweight exposure in selected names in Korea, Taiwan, Thailand and Singapore markets

In March, the MSCI Asia Pacific ex Japan (MXAPJ) index posted a positive return of 2.29% (USD terms). Among the Asia Pacific ex Japan markets, Taiwan was the outperformer (+7% mom) driven by AI beneficiaries such as TSMC and Hon Hai as well as high yielders led by strong inflows into local high dividend ETFs. Korea market was second in line led by Technology and Healthcare despite some profit taking activities seen in the value space ahead of the National Assembly election. HK/China markets held up with market participants now debating on the sustainability of China marco data after a strong set of data that was released for Jan-Feb period as well as the possibility of a QE following SCMP's report of President XI telling PBoC to restart CGB trading. The India market appeared to have stalled with Technology, Property and mid-caps pulling back. Among the ASEAN markets, Singapore outperformed led mainly by the banks as attractive yield plays. During the month, gold reached an all-time high of US\$2,229.9 per ounce as an inflation back. hedge. DXY remained resilient during the month to close at 104.49.
